

Meeting with Your Local Legislator and their Staff

Before The Meeting

Know Our Issues

Take the time to educate yourself and your team on the legislative issues that impact your organization and others in the Alliance. Visit pages six and seven to find our TACFS policy priorities and talking points.

Learn The Process

Our Texas Legislature only meets for 140 days! There are many barriers to creating and passing policy in that short time. Know that the Session goes quickly. Being a reliable resource to your member will make you an effective advocate. And we'll keep you posted on key points to stay engaged as the Session continues!

At The Meeting

Be Honest

Give a true and specific account of your story and knowledge. Use this time to educate and encourage your lawmaker. If you aren't sure of something, just say so! Be sure to provide the needed information later by email or phone.

Be Kind

Make your points persuasive and succinct (You may only get 5-15 minutes!) while finding common ground. We want to work with our representatives, not against.

Be Specific

Always end on a specific ask. What exact legislation, rider, amendment, bill do you want them to support? How exactly can they act to serve Alliance members, kids, youth, and families?

Be Personal

No one knows your story better than you. Legislators remember when they know the direct impact their work has on constituents. Your stories about kids and youth who need our organizations are memorable, impactful, and indisputable.

After the Meeting

Follow Up

There are lots of ways to contact your legislator.

At their office in their district or at the Capitol



TACFS Legislative Priorities

Where children, youth, and families need support — TACFS members are partnering with the state to keep kids safe and families together. Our members are the direct care providers of services including prevention, family preservation, foster care, adoption, and more. Our work cannot happen without the Legislature and their long-standing commitment to meaningful child-focused reforms and an investment in strong services that support improved outcomes.

WE SUPPORT STRENGTHENING FAMILIES.

TACFS members support families across the continuum to promote stability and keep families safe and together.

Support DFPS' legislative appropriation request to expand proven, community-driven primary prevention



programs, including HOPES, Family Resource Centers, Community Youth Development, and Family and Youth Support. These programs keep families safe and supported before the need for CPS intervention.

Continue the HB 3041 (87R) family preservation pilots, building evidence -based services for children and families at imminent risk of removal.

Invest federal Family First Transition Act funding in developing evidence-based family preservation programs in communities.

Increase post-adoption and post-permanency funding in DFPS budget to provide support to keep families stable and prevent foster care reentry.



WE SUPPORT MENTAL HEALTH CARE FOR YOUTH AND ADOLESCENTS.

Mental health care is a critical component across all touchpoints of the system. TACFS members are responding to the national and statewide crisis to support struggling youth and adolescents before more significant intervention is needed.

Support increased funding for the RTC (Residential Treatment Center) Project at HHSC, a program targeted to keep youth in crisis or with significant behavioral health needs out of foster care through short-term intensive treatment and support for families.

Direct HHSC to review SB 58 Medicaid credentialing processes and services for child welfare providers. Credentialed providers offer intensive mental health services for youth and adolescents, but this credentialing is difficult to obtain, and the service array should be reviewed for the STAR Health, or foster care, population.

WE SUPPORT CHILD-CENTERED OVERSIGHT AND REGULATION.


The Legislature can support positive and child- centered oversight and reduce the negative impact of a confusing and at times, punitive system.

Direct HHSC to contract with a third-party national expert to review and make recommendations on foster care licensing standards with a core focus on child safety and wellbeing.

Provide legislative direction on oversight of care for children with complex needs and behaviors such as runaway, self-harm, or

aggressive behavior to keep kids more stable and to offer therapeutic care, review processes for documenting behaviors, and improved technical assistance.

Support efforts to address child welfare providers risk and lack of access to liability insurance coverage. It is increasingly difficult and expensive to obtain required insurance coverage due to a shortage of insurance carriers and skyrocketing premiums, threatening the sustainability of high- quality providers and making it difficult for organizations to build capacity for children with complex needs.



WE SUPPORT BUILDING AND SUSTAINING HIGH -QUALITY PLACEMENTS AND SERVICES.

The Legislature funds and supports capacity through rates and contracts with TACFS members. Appropriations investments in these areas will support ongoing development and sustainability of high -quality care and placements.

Maintain temporary rate increases established by HB 5 (87S2) and include settings not currently covered, such as emergency shelters.


Invest broadly in foster care rate increases to support the child-serving workforce.

Implement and fund foster care rate modernization, an ongoing priority of the Legislature (86R, 87R) to update calculations to accurately reflect the cost of care and prioritize quality and outcomes.

Support DFPS' request to continue implementation of Community-Based Care in new regions. Continue investment in flexible capacity building funding to support developing high quality foster care and keeping children out of unlicensed settings. Consider investments to support technology and IMPACT interoperability.

Did You Know?

- 1. While in the central rotunda, be careful what you say! Even your whispers can be heard throughout the gallery, because the sound waves travel the circumference of the rotunda and cling to the walls as it circulates around the inside of the dome. That's correct! This phenomenon is known as a "whispering gallery"
- 2. In the central rotunda, you'll find portraits 6. You can view the monumental statues of of all the past presidents of the Republic of Texas and governors of the state of Texas.
- 3. If you stand directly in the center of the 7. Discover the six sovereign nations that have rotunda and look straight up into the dome, vou will see a star with the letters T-E-X-A-S - each individual positioned between the points of the five-pointed star. The star 8. The Texas Capitol's ornate hardware seems small from your vantage point, but it is actually bigger than you! 8 feet to be exact.
- 4. "Everything is bigger in Texas" so the saying goes, and that is exactly what you might think when you visit the Texas State Capitol. Standing proudly in the capital city of Austin, at just over 302 feet, it is the sixthtallest state capitol is even taller than our nation's Capitol.
- 5. This is actually the third Capitol building in the history of the Lone Star State. It stands

on the same site of the second Capitol that was destroyed in a fire in 1881. (The first Capitol was in Columbia, Texas). The current Capitol was built by 900 workers consisting largely of convicts and migrants, including 86 granite cutters brought over from Scotland. Their job was to cut the red granite that came from nearby Marble Falls.

- Stephen F. Austin and Sam Houston in the South Foyer.
- governed Texas on the floor of the Rotunda and at the E2 entrance to the extension.
- will stop you in your tracks. Designed by architect Elijah E. Myers in 1881, the building is ornate and elegant. Carved door-knobs on the heavy exterior doors welcome those arriving, transporting them in time to a European city. Doorknobs, handrails and kick plates are just a few of the hardware pieces that decorate the Texas Capitol.
- 9. The outdoor rotunda is almost as cool as the one inside. Everyone knows about the Capitol's rotunda. The circular center chamber of the Capitol sits beneath a

double-walled dome with inner wall peaking at 218 feet above the floor. The rotunda is a common feature among historic government buildings. But did you know there's another one on the Capitol grounds? The Capitol Extension is an underground building directly north of the Capitol beneath the northern grounds. Windows allow abundant natural light to fill the Extension's corridor and arterial central hallways. The outdoor rotunda sits at the middle of the central corridor.

10. The immaculate grounds are filled with monuments. The 22-acre expanse is filled with monuments waiting for your discovery. More than 20 monuments are scattered about the grounds. They honor a wide range of people and events including peace officers, disabled veterans, Texas pioneer women and heroes of the Alamo-just to name a few. The latest addition is a monument to African-American history unveiled in 2016.
