The Center was established in 2000 and we are continuously evolving in response to the always-changing nature of the work we do. Current Opportunity

We are seeking individuals to build a pool of affiliate consultants and other professionals to work alongside the Center team to provide a full continuum of support to help child, youth and family service providers operate and thrive in a rapidly evolving environment. Our intention is to find individuals who are solution-focused and able to produce actionable recommendations, hands-on improvement, or other needed support for organizations to maximize impact in their communities. The time commitment will be dependent on the scope of activities in individual projects.

Responsibilities

Affiliated Professionals will provide consulting, training, and/or technical assistance on client engagements within a defined scope of work and project budget, serving as project lead with one or multiple staff. Depending on the affiliate contract this may include:

- Establish and maintain strong ongoing relationships with the Center's staff, clients, and other stakeholders
- Lead, manage and support teams of staff, board, and volunteer leaders throughout the project
- Analyze client challenges and goals, offering constructive, objective, and actionable recommendations, hands-on improvement, or other needed support
- Assist the client in implementing recommendations/solutions and ensuring the client receives the necessary assistance to make projects successful
- Communicate with the client to keep them informed of progress, make relevant decisions, and serve as a trusted advisor
- Develop new tools, products, trainings, and services that address client and organizational needs
- Deliver training and workshops focused on nonprofit capacity building, professional development, race equity, trauma-informed practices, compliance strategies, leadership development, succession planning, nonprofit governance, organizational sustainability, and other focus areas

Qualifications

We are looking to engage affiliate consultants for both in-person and virtual projects. While we prefer individuals who are knowledgeable about and have experience working with or in the Texas child welfare system, we welcome applicants from across the United States. An affiliate is a self-employed individual who is contracted to perform work. An affiliate is not an employee of TACFS or the Center, although coordination with the Center may be expected. Affiliates will be expected to use their own personal equipment for all project activities. Access to specialized software can be provided as necessary for the project.
