### 89th Texas Legislature: A Snapshot

- Sine die Adjourn "without a day" at end of 140-day Regular Session (June 2)
- Record number of bills passed and a robust budget
- Everything changes, but stays the same
  - New leadership in the House, Same leadership in the Senate

#### **89th Bill Stats**

8,719

bills filed (more than ever recorded in either chamber)

bills received public hearings

39%

bills passed out of either chamber

25%

14%

bills finally passed and sent to the Governor

# **Family Preservation**

- Family preservation programs a permanent part of the continuum of services available to Texas families.
- Texas Family First pilots a permanent part of Community-Based Care.
- Family preservation beyond FFPSA-eligible services

*Key themes*: Families should be able to access high-quality, appropriate services that prevent entry into foster care and ensure families can stay safely together. Services should be coordinated as part of CBC contracts.



# **Family Preservation**



**\$22.9 million** in general revenue (state funds) to continue the work started in the Texas Family First Pilots (now the Texas Family First and Enhanced Family Engagement Pilots)

- Pilots will continue to serve court-ordered services cases but can also serve other children at imminent risk of removal, including to prevent parental relinquishment (subject to available funds and DFPS approval).
- SSCCs (to the extent funds are available) also implement enhanced family engagement efforts in conservatorship.\*

\*DFPS Rider 41, SB 1398, Contingency Rider 18.59



### **Family Preservation – Other Laws**

#### HB 116 | Dutton Removes the "O" ground for termination.

#### HB 1106 | Shaheen A/N definition does not include refusal to affirm gender or sexual orientation.

#### HB 1151 | Hull Alternative health or refusal of psychotropic meds is not abuse/neglect.

SB 2018 | Paxton Allows tax breaks for contributions to orgs that serve at-risk families.

# Liability & Regulatory



#### Continue to refocus regulatory scheme on child safety

- HB 2789 (Frank) is SB 593 2.0. removes CPA licensure requirement for SSCCs, TB testing requirements, minimum liability insurance requirements, trespass posting and more.
- Ensure better access to liability insurance for non-profit foster care providers
  - SB 1558, landmark legislation that sets a national standard for improved access to liability insurance. Charitable Immunity and Liability Act protection for non-profit providers and "good standing" framework for vicarious liability protection.
- **Key themes:** Foster care providers need a focused and intentional regulatory framework, paired with access to liability insurance that allows them to continue to serve children and families.



#### **89th Legislative Recap**

#### Liability & Regulatory – Other Laws

HB 140 | Noble Investigations council at DFPS, training/compliance with procedures.

#### HB 1403 | Harris

Disallows CPA/HHSC/DFPS from asking about guns, specifically the types of firearms or if any changes in firearms occur, financial penalty.

#### HB 3153 | Kerwin

Background checks and reference checks, includes an exemption that our checks are already sufficient. HB 3597 | *Hickland* Public hearing for GROs in counties less than 500,000. HB 5394 | Rose Prohibit additional requirements on kinship caregivers.

### **Mental Health**

- **\$40 million** in additional funds at HHSC for youth mobile crisis outreach teams.
- HHSC SMART Innovation Grant funding continued
- \$92.6 million in additional funds at HHSC for rate increases and expanded capacity at community mental health hospitals.

#### **Mental Health – Other Laws**

#### HB 1151 | Hull

Alternative health or refusal of psychotropic meds is not abuse/neglect.

SB 855 | Sparks Allows foster parents to pay out of pocket for services outside of Medicaid.


### CBC

- CBC continuation and expansion
- \$2,500 network support payment
- Funded early payments to the SSCCs during Stage I and II readiness



### **CBC** Map

**SB1** (FY 26-27 Budget) continued funding for existing regions and funds expansion into 7A, 7B, 11A, 11B and a pilot for 9 and 10



\*Cook, Denton, and Wise counties in 3W are in Stage II



### **CBC – Other Laws**

HB 4129 | Davis, Aicha DFPS must implement formal measures for CBC to ensure quality, including financial interventions, quality improvement plans, etc.

#### **SB 513 | Sparks** CBC pilot in West Texas

SB 1589 | Hancock Individual or wholesale Case management takeover by DFPS SB 2032 | Paxton SSCC/DFPS can't terminate without 180 days notice, may enter into contract with another SSCC to take over

SB 2034 | Paxton Allows for SSCC receivership in limited circumstances

## Support for Children and Youth



- **HB 451:** Developmentally appropriate human trafficking screening for children entering care.
- **HB 1211:** Extend deadline for enrollment from age 25 to age 27 to take advantage of the Tuition Fee Waiver.
- HB 4655: PAL classes include financial info about credit scores, payday loans, car loans, and more.
- **SB 2165:** Prohibition of case closure while children are missing or on runaway.

### Budget







- T3C rates fully funded and \$12 million in grant funds continue!
- Expanded daycare access for kinship placements
- Funded GR match for federal funds for transitional living services
- Continued and expanded UTHSC contract for RTC services
- Funded some DFPS resources for more consistent RTB findings and Due Process timeliness
- Funded some technology improvements including revamped "IMPACT," SEMARC, and cybersecurity



### Budget Highlights





- HHSC Rider requiring STAR Health Service Coordination
- Included TACFS rider requiring improved Medicaid Credentialing process
- Included TACFS rider for additional Heightened monitoring information on types of facilities, when they entered HM, licensed/actual capacity, and number of DFPS/HHSC staff tasked with HM.


